DRIVING DOWN STREET AND OIL LIGHT CAME ON..PROCEEDED TO STORE AND PUT OIL IN CAR, DROVE APPROXIMATELY 10 MILES AND OIL LIGHT CAME ON AGAIN. THEN I DETERMINED THAT ALL THE OIL HAD DRAINED OUT. OIL IS POURING OUT OF MY CAR FASTER THAN I CAN PUT IT IN. SEARCHING ON THE INTERNET I'VE FOUND THAT OTHER HONDA ACCORD OWNERS OF THE 1996 MODEL HAD THE SAME PROBLEMS. I EVEN NOTICED THAT ONE HAD A RECALL FOR THE DAMAGED PART. I HAVE NO RECALL AND HAVE LIVED IN THE SAME LOCATION..JUST 5 MINUTES FROM THE HONDA DEALER WHERE THE CAR WAS PURCHASED. MY CAR IS SOAKED IN OIL FROM THE FRONT TO THE BACK..TIRES INCLUDED. I'M SURPRISED IT DIDN'T CATCH FIRE. PEOPLE NEED TO BE AWARE OF THESE DEFECTS AND SHOULDN'T HAVE
