### NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

**DURING THE TIME OF THE JUNE '01 FAILURE I DIDN'T REALIZE THERE WAS A PROBLEM. MY FAMILY AND I HAD JUST ENTERED A LOCAL ROADWAY WHEN A DEER CROSSED IN FRONT OF US. I APPLIED THE BRAKES AND IT WAS LIKE STEPPING ON A ROCK. I WAS UNABLE TO DEPRESS THE BRAKE. THE BRAKES HAD JUST WORKED FINE AS WE ENTERED THE HIGHWAY AND THEY WORK FINE AFTER THIS INCIDENT. I HAD NEVER HAD ANYTHING LIKE THIS HAPPEN PREVIOUSLY. NOR DID I REALIZE AT THE TIME THIS WAS GOING TO BE A REOCCURING PROBLEM. ON OCTOBER 6, '01 I WAS TRAVELING ALONG A RESIDENTIAL ROADWAY WHEN A CAR STOPPED IN FRONT OF ME I WAS TRAVELING AT A SAFE DISTANCE AND GOING APPROX 45MPH. I SHOULD HAVE HAD PLENTY OF TIME TO STOP. HOWEVER, I ONCE AGAIN WAS UNABLE**
