LOOSE STEERING, SECOND (REPLACEMENT) STEERING GEAR. THE ORIGINAL STEERING GEAR WAS NOISY AND THE DEALER REPLACED IT WITH A USED, REBUILT UNIT AT 3,264 MILES. CURRENT (USED) GEAR HAS EXCESSIVE FREE PLAY, THE VEHICLE WANDERS AND IS DIFFICULT TO CONTROL ON THE HIGHWAY. FORD REFUSES TO SUPPLY THE DEALER WITH A NEW GEAR. THE DEALER REFUSES TO REPLACE OR ADJUST THE LOOSE GEAR. I FEEL THE SAFETY OF THE VEHICLE IS IN QUESTION WITH THE USED GEAR IN IT DUE TO LACK OF TRACEABILITY OF THE GEAR IN CASE OF A RECALL OR SAFETY CAMPAIGN. *AK
