SINCE THERE ARE HUNDREDS OF OTHER IDENTICAL COMPLAINTS ABOUT THE 1996 WINDSTAR 3.8L ON THIS WEBSITE, I FIND FORD'S DENIALS PRETTY HARD TO BELIEVE! THIS HAS CREATED A SERIOUS FINANCIAL HARDSHIP, AND FORD HAS REFUSED TO COMPENSATE IN ANY WAY FOR THE OBVIOUSLY DEFECTIVE PART. I AM REQUESTED THAT YOU PROCEED WITH AN INVESTIGATION, AND WILL BE CONTACTING MY SENATORS AND REPRESENTATIVE. *AK
