THESE ROTORS HAVE FAILED EVERY 2 YRS/ 20K MILES. I HAVE NEVER REPLACED ROTORS ON A VEHICLE, LET ALONE THAT OFTEN. THESE ROTORS NEED TO BE RECALLED THEY ARE DEFECTIVE. I HAVE BEEN TOLD BY MY SERVICE PERSON AT COCHRAN AND BY ANOTHER MECHANIC WHICH SEVICES MY OTHER DAR THAT RODEO ROTORS HAVE ALWAYS HAD TROUBLE. WHY ARENT THEY ON A RECALL LIST? THIS COSTS ME 6-800.00 DOLLARS AT EACH FAILURE!! I AM GRATEFUL IT DIDNT COST MY LIFE. THERE ARE NO SQUEELERS TO WARN / IN 10 MILES FROM WORK, MY BRAKES STATRED TO GRIND THEN GOT WORSE
