MY VEHICLE WAS BUILT ON APRIL 30, 2001 AND PRICED TO INCLUDE THE RADIATOR UPGRADE. THE VEHICLE WAS BUILT WITHOUT THE UPGRADE. I PAID FOR THE UPGRADE WHEN I BOUGHT THE VEHICLE (JUNE 2001) AND DID NOT GET IT. I FEEL THAT FORD SHOULD INCLUDE MY VEHICLE IN THIS RECALL AS IT WAS BUILT AND PRICED BEFORE THE CUTOFF DATE AND I DID NOT GET THE UPGRADE THAT I PAID FOR. *AK
