NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

I HAVE EXPERIENCED MULTIPLE FAILURES OF THE ABS SYSTEM SINCE PURCHASE. THE PROBLEM WAS INTERMITTENT AND GENERALLY AT SPEEDS OF LESS THAN 20 MPH ON DRY ROADS. I WOULD ESTIMATE NO FEWER THAN 25 FAILURES IN TWO YEARS WHEREIN THE BRAKES FAIL TO ENGAGE PROPERLY AT LOW SPEED CAUSING THE VEHICLE STOPPING DISTANCE TO BE EXCESSIVE. WHEN BRAKING, THE BRAKES OFTEN FAILED TO ENGAGE PARTICULARLY AT ROUGH INTERSECTIONS. IT FEELS AS IF THE VEHICLE SLIDES OVER THE BUMPS. NOW THE ABS LIGHT CAME ON AND REMAINS LIT. THE ABS UNIT ITSELF RUNS EVEN WITH THE MOTOR OFF. I HAVE REMOVED THE FUSE AND DISENGAGED THE ABS WHICH ALLOWS THE VEHICLE TO OPERATE SAFELY ALTHOUGH THERE IS NO ABS ACTIVE. WITH THE ABS
