I WAS DRIVING ON A TWO LANE CURVING ROAD WITH THE BRIGHTS ON. WITHOUT WARNING THE LIGHTS WENT COMPLETELY OUT. I WAS ABLE TO PULL THE SWITCH BACK TO THE REGULAR POSITION AND THEY LUCKILY THEY CAME BACK ON. I WAS UNABLE TO GET A REPLACEMENT ON SATURDAY BECAUSE THE DEALER WAS DOING INVENTORY. THE SWITCH ALSO FAILED SEVERAL OTHER TIMES OVER THE WEEKEND WITH THE REGULAR HEADLIGHTS AS WELL. I CONTACTED THE DEALER FOR A REPLACEMENT SWITCH AND ASKED HIM IF THEY HAD BEEN REPLACING MANY OF THESE AND HE TOLD ME YES. I THEN PROCEEDED TO TELL HIM HOW IT TRIED TO KILL ME AND MY FAMILY. I HAVE METERED THE REPLACEMENT SWITCH AND IT SHOWS READINGS ALL OVER THE PLACE AS FAR AS RESISTANCE, IN
