VEHICLE STALLED WITHOUT WARNING WHILE DRIVING @~30MPH. THIS HAS HAPPENED SEVERAL OTHER TIMES ON THE ROAD. DEALER HAS PERFORMED REPAIRS 3 OTHER TIMES AS FOLLOWS: VISIT 1 - CHANGED FUEL PUMP RELAY, VISIT 2 - CHANGED ECM MODULE RELAY, VISIT 3 - REPLACED FUEL PUMP AND SENDER. DEALER SERVICE HAS INDICATED THAT THEY WERE UNABLE TO FIND EXACT CAUSE OF STALLING, SO THEY ARE REPLACING COMPONENTS IN HOPES OF CATCHING THE PROBLEM. AFTER VEHICLE STALLED, POWER STEERING AND BRAKES WERE NON-FUNCTIONAL AND I ONCE AGAIN NEEDED TO PULL OFF THE ROAD EVASIVELY TO AVOID REAR-ENDING THE CARS IN FRONT OF ME.
CLARIFICATION: THIS MOST RECENT STALLING INCIDENT OCCURED TODAY, EVEN AFTER THE FUEL PUMP
