ANYONE CAN MOVE THE SHIFT LEVER FROM PARK TO REVERSE WITHOUT TOUCHING THE BRAKE. THIS IS VERY DANGEROUS. NO ONE HAS TO BE IN THE DRIVER SEAT, A CHILD CAN BE IN BETWEEN THE DRIVER AND PASSENGER SEATS, TAKE HOLD OF THE SHIFT LEVER AND PULL IT DOWN INTO GEAR. WE CONTACTED SOUTHLAND DODGE AND THEY SAID THEY ALL DO THIS. THIS IS NOT RIGHT. ALL OTHER VEHICLES YOU HAVE TO DEPRESS THE BRAKE BEFORE YOU CAN SHIFT OUT OF PARK. THIS REPORT WAS SENT TO YOU ONCE BEFORE ON 6/3/01 WITH NO RESPONSE. *AK
