SPARE TIRE HOIST CABLE FATIGUED NEAR WHEEL RETAINER AND TIRE FELL FROM VEHICLE; THEFT DETERRENT CABLE KEPT TIRE FROM FALLING COMPLETELY AWAY AND CAUSED TIRE TO LIFT THE REAR END OF MY TRUCK. THERE IS NO APPARENT DAMAGE OTHER THAN A BENT REAR LICENSE PLATE. I FEAR THAT THIS MAY HAPPEN TO SOMEONE AT HIGHWAY SPEEDS CAUSING LOSS OF CONTROL OR IF THEFT DETERRENT CABLE IS NOT IN PLACE THE TIRE MAY FALL FROM UNDERNEATH THE VEHICLE AND STRIKE ANOTHER VEHICLE OR CAUSE A ROAD HAZARD. I WAS FORTUNATE TO BE A FEW HUNDRED FEET FROM MY HOME WHEN THIS HAPPENED. THE CABLE APPEARED TO BE FATIGUED AT THE POINT WHERE THE BREAK OCCURED. PLEASE CONTACT ME TO ASSURE THAT THIS INFORMATION IS PROCESSED. THANK YOU.
