ENGINE CHECK LIGHT CAME ON AT ABOUT 72,000 MILES. TOOK THE CAR IN TO LEIGHT HONDA AND THEY TOLD ME TO REPLACE THE SOLENOID. I PAID \$400 AND IT WAS REPLACED. ABOUT 1,000 MILES LATER THE ENGINE CHECK LIGHT CAME BACK ON. THIS TIME TOOK IT TO AUTO PARK HONDA IN CARY, NC. IT HAD A TORQUE CONVERTER FAILURE CODE AND TRANSMISSION WAS REPLACED WITH A NEW TRANSMISSION. I HAVE HAD THE REPAIRED VAN BACK FOR TWO WEEKS AND THE ENGINE CHECK LIGHT HAS COME BACK ON AGAIN.
