I HAVE A 2001 DODGE SPORT PICKUP 4X4 THAT CAUGHT FIRE. THE POINT OF ORIGIN WAS LOCATED ON TOP OF THE FUEL TANK WHICH CAUSED THE FUEL TANK TO RUPTURE AND CATCH FIRE. THIS OCCURRED WHILE THE VEHICLE WAS BEING DRIVEN. NO MECHANICAL PROBLEMS PRIOR TO THIS INCIDENT. FIRE WAS CONFINED MAINLY TO THE UNDERSIDE OF THE BED. I HAVE FOUND WHERE THIS IDENTICAL THING OCCURRED ON THE 1998 MODELS AND A RECALL 98V182000 FOR THAT MODEL TRUCK ON FUEL LINE PROBLEMS WAS ISSUED. AFTER EXAMINING MY TRUCK, THE DEALER SAYS THAT THEY HAVE NEVER SEEN OR HEARD OF THIS BEFORE AND THAT THEY ARE NOT TRAINED TO DETERMINE THE CAUSE OF THIS FIRE. I NEED SOMEONE TO INVESTIGATE THIS PROBLEM. I HAVE NOT CONTACTED THE M
