I THINK VOLKSWAGEN AMERICA SHOULD CONSIDER THAT MAYBE THE PROBLEM GOES FURTHER BACK AND NOT DISMISS IT BECAUSE IT DOESN'T SHOW UP ON THE COMPUTER. THE VOLKSWAGEN DEALER STATED THAT THE CAR NEEDS FRONT TIE ROD ENDS WHICH IS EXACTLY WHAT IS DESCRIBED IN THE RECALL. IF I GOT THE INFORMATION CORRECT MY CAR WAS MFG 11/97 WHICH IS EARLIER THAN THE RECALL. IF THE PROBLEM IS DESCRIBED THE SAME. THEY ARE SAYING THAT IF ITS NOT ON THEIR COMPUTER IT'S NOT
