TRIBUTE WAS PURCHASED WHILE "AT SEA." 48 HOURS AFTER TRIBUTE WAS ROLLED OFF THE DELIVERY TRUCK THE ENGINE SHUTOFF WITHOUT PRIOR WARNING WHILE TRAVELING U-HILL AT 45MPH. IT SHUT OFF AGAIN SIX DAYS LATER WITHOUT WARNING. ACCORDING TO EDMUNDS.COM WEB SITE, MANY OTHER TRIBUTE AND FORD ESCAPE OWNERS ARE HAVING THE SAME STALLING PROBLEM. HENNESSEY MAZDA HAD 3 TRIBUTES RETURNED TO THEIR DEALERSHIP FOR SAME PROBLEM PRIOR TO MY PURCHASE DATE OF 10/30/01. BOTH HENNESSEY AND MAZDA CORP HAVE REFUSED TO GIVE ANY TYPE OF CERTIFICATION OR GUARANTEE THAT THE CORRECTIVE REPAIRS PERFORMED ON MY TRIBUTE ON 11/8/01 ARE THE PERMANENT FIX. *AK
