LEFT REAR TREAD SEPARATED FROM THE TIRE WHILE TRAVELING AT 70MPH ON AN INTERSTATE HIGHWAY.AFTER STOPPING TO CHANGE THE TIRE, IT WAS NOTED THAT THE TIRE TEMPATURE WAS 150DEGREES (COMPARED TO 130DEGREES ON THE 3 REMAINING TIRES), AND THE TIRE CONTINUED TO HOLD 50LBS OF AIR. NO INJURIES WERE SUSTAINED BY PASSENGERS, BUT THE TIRE TREAD CAUSED \$4,206 IN DAMAGE TO THE MIDDLE AND REAR PANELS OF THE SUBURBAN.*AK
