1999 DODGE INTREPID ES 34000 MILES: STEERING INTERMITTENTLY IS VERY LOOSE AND AWKWARD, STEERING SOMETIMES IS TIGHT LIKE IT SHOULD BE. STEERING WHEEL HAS LIMPED TO THE LEFT SEVERAL TIMES WHILE STOPPED OR DRIVING SLOW AND STEERING FEELS REALLY STRANGE. WHEN STEERING WHEEL IS MOVED BACK AND FOURTH QUICKLY ONLY FROM LEFT TO CENTER WHEN VEHICLE IS STOPPED THERE IS SLIGHT KNOCK OR BUMP SOUND IN STEERING. STEERING WHEEL JERKS TO THE RIGHT DURING MEDIUM TO HARD OR HARD ACCELERATION SOMETIMES IN AUTOMATIC USUALLY IN AUTOSTICK. WHEN STEERING WHEEL DID NOT FUNCTION AND RETURN AS USUAL A COUPLE TIMES I ALMOST WOUND UP IN AN ACCIDENT. VEHICLE SOMETIMES ALSO SWAYS FUNNY WHEN STEERING IS ACT
