TRAVELING I-71N, 6:30 A.M. TOUCHED GAS PEDAL TO PASS ANOTHER VEHICLE. ACCELERATOR DROPPED TO THE FLOOR AND STUCK. VEHICLE CONTINUED TO GAIN SPEED AND WOULD NOT SLOW DOWN. BRAKED AS HARD AS POSSIBLE AND MANAGED TO GET VEHICLE TO 50 MPH. THREW VEHICLE INTO NEUTRAL TO GET IT TO SLOW DOWN AND STOP GAINING SPEED, MOTOR CONTINUED TO RACE EXCESSIVELY. VEHICLE TOWED TO SANTA FE AUTOMOTIVE, PARMA, OHIO.
