GAS GAUGE STOPS WORKING AT ABOUT < TANK. AFTER REACHING THAT LEVEL, THE GAUGE PEGS TO PAST THE FULL LEVEL AND DOES NOT WORK AGAIN UNTIL THE TANK IS FILLED AGAIN. *AK
