EVENTUALLY THIS WOULD FAIL COMPLETELY AND WE WOULD LOSE THE PROPER FUNCTION OF THESE COMPONENTS (WHICH IN MY MIND IS A SAFETY HAZARD AND SHOULD BE RECALLED/FIXED FREE OF CHARGE BY CHRYLSER. *AK
