MY VEHICLE IS A 2001 FORD ESCAPE V6 XLT 4X4 PURCHASED NEW (0 MILES) IN AUGUST. ON NOV. 28, 2001, IN THE MORNING, AFTER ABOUT 8 MINUTES OF RUNNING AND LESS THAN A MILE OF DRIVING, I WAS GOING DOWN A HILL (ON RAMP TO HIGHWAY). I HAD ACCELERATED TO A COAST OF ABOUT 35-40 MPH AND WAS ABOUT TO ACCELERATE AGAIN WHEN THE VEHICLE COMPLETELY SHUT OFF, MANY INDICATOR LIGHTS APPEARED (AS A RESULT OF THE KEY BEING IN THE RUN POSITION), POWER BRAKES AND STEERING WERE LOST. I SHIFTED THE VEHICLE TO NEUTRAL AND RE-STARTED WHILE MOVING TO AVOID A REAR-END COLLISION. I REPORTED THE INCIDENT TO THE DEALER AS SOON AS POSSIBLE AND THEY SCHEDULED ME FOR 2 DAYS LATER. THE PERSON ON THE PHONE WAS AWARE OF FORD ESCAPES
