THIS APPEARS TO BE A COMMON PROBLEM WITH THIS MAKE/MODEL OR SIMILARLY CONFIGURED BATTERY CABLE SYSTEM. THE POST BREAKS OFF INSIDE THE BATTERY AS A RESULT OF VIBRATIONS AND THE WEIGHT OF THE CABLE. THE CONSUMER MUST BUY A NEW BATTERY AS A RESULT. FURTHERMORE, THE BATTERY BOLT FREEZES INSIDE THE CABLE REQUIRING IT TO BE CUT OUT DUE TO THE EXCESSIVE HEAT GENERATED AT THE CONNECTION. THIS IS A COMMON PROBLEM WITH THIS VEHICLE ACCORDING TO THE TECHNICIAN I SPOKE WITH AT BENTLEY PONTIAC AT THE TIME I TOOK IT IN. I HAD TO HAVE THE VEHICLE TOWED TO GET IT REPAIRED. WHEN I PICKED MY VEHICLE UP, I NOTICED ANOTHER BONNEVILLE GETTING IT'S BATTERY REPLACED FOR THE EXACT SAME PROBLEM - TH
