NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

WHEN PURCHASED, THIS CAR WAS SERVICED, INCLUDING A COOLING SYSTEM INSPECTION. I ALSO NOTIFIED FORD BY TELEPHONE THAT I HAD PURCHASED THE CAR, PROVIDING THE VIN. I WAS TOLD THAT THERE WERE NO RECALLS ON THE CAR AT THAT TIME. THE COOLING SYSTEM WAS CHECKED 4 MONTHS AGO, AND WAS FINE AT THAT TIME. SEVERAL DAYS AGO, THE CAR OVERHEATED, SPEWING COOLANT WHEN THE HOOD WAS LIFTED. I DID NOT, AT ANY TIME ATTEMPT REMOVAL OF THE COOLANT CAP; THE COOLANT WAS SPEWING FROM BENEATH THE CLOSED CAP. MY MECHANIC FOUND THAT THE COOLING SYSTEM IS COMPLETELY CONTAMINATED WITH RUST AND SLUDGE. HE ALSO TOLD ME THAT FORD HAD A RECALL ON THE SITUATION. WHEN I CALLED FORD, THEY TOLD ME THAT THE RECALL WAS
