TIRE WAS REPLACED BY FIRESTONE DEALER SAME DAY, I WAS CHARGED FOR THE MOUNTING AND BALANCING. TIRE WAS REPLACED BY FIRESTONE DEALER SAME DAY, I WAS CHARGED FOR THE MOUNTING AND BALANCING.
