SECOND CAMSHAFT FAILURE WITHIN ONE YEAR. REPAIRING DEALER WAS REQUESTED TO CHECK VALVE TAP IN SEPTEMBER. ORIGINAL CHAMSHAFT REPAIR WAS DONE HOWEVER CAR CONTINUED TO EXPERIENCE ENGINE PRESSURE AND TIMING PROBLEMS. REQUESTED SERVICE DEALER TO CHECK VALVE TAP IN SEPTEMBER 2001. DEALER REFUSED TO DO SERVICE, EXPLAINED THAT THE PROBLEM WAS ABOVE THEIR HEADS. COMPLAINED NUMEROUS TIMES TO FORD CONCERNING REPAIR AND DEALER'S RESPONSE. DEALER NOW BELIEVES CAR NEEDS NEW ENGINE. INITIAL REPAIR WAS \$3000 AND TOOK TWO MONTHS. FORD HAS BEEN AWARE OF THE FAILURE OF THE CAMSHAFT SPROCKETS FOR AT LEAST 3 YEARS. HOWEVER, NO ACTION HAS BEEN INITIATED TO REPAIR ALL PROBLEMS AT ONE
