FRONT FENDER TIP LIGHT WIRE RUBS AGAINST TIRE, CAUSING WIRE TO FRAY AND MAKE CONTACT CAUSING THE LIGHT FUSE TO SHORT OUT. ALL HEAD LIGHTS, AUXILLIARY DRIVING LIGHTS, RUNNING LIGHTS AND MARKER LIGHTS GO OUT. THIS HAPPENING AT NIGHT AT HIGHWAY SPEEDS COULD PROVE TO BE FATAL.
