THIS VEHICLE EQUIPPED WITH OUTSIDE "SIGNAL" MIRRORS (RED LEDS BEHIND GLASS). THE RIGHT SIDE MIRROR HAS SUFFERED A SIGNIFICANT LOSS OF REFLECTANT MATERIAL FROM THE SURFACE, REDUCING VISIBILITY TO ABOUT 40% OF ORIGINAL (SATISFACTORY ONLY IN BRIGHT DAYLIGHT). THE LEFT SIDE MIRROR HAS BEGUN TO LOSE REFLECTANT (CURRENTLY ABOUT 10%). THIS WAS POINTED OUT TO THE SHOP FOREMAN AT THE DEALER, BUT SINCE THE VEHICLE IS OUT OF WARRANTY, HE OFFERED NO SOLUTION. REPLACEMENT WOULD COST SEVERAL HUNDREDS OF \$ AT FORD PRICES, DIFFICULT TO FIND NON-OEM REPLACEMENTS. SHOP FOREMAN MENTIONED THAT HE HAD HEARD OF OR SEEN THIS S FEW TIMES IN PAST. I HAVE OWNED NUMEROUS VEHICLES INCLUDING SEVERAL FORD
