I HAVE DISCOVERED THE TRANSMISSION DIP STICK/FILL CAP MISSING ON THREE SEPARATE OCCASIONS. UNKNOWN HOW LONG I DROVE WITHOUT DIP STICK EACH TIME. FIRST TIME I HAD THE TRANSMISSION FLUID PURGED, BUT DEALER STATED PLUG MUST HAVE WORN OUT. EACH TIME THE FLUID LEVEL BECAME VERY LOW. I BELIEVE AN INTERNAL PREASURE IS CAUSING THE PLUG TO BLOW OUT. I HAVE SINCE TIED A STRING TO THE PLUG SO THAT I WILL NOT LOSE THE PLUG. UNKNOWN DAMAGE TO TRANSMISSION DUE TO LOW FLUID OR DIRT CONTAMINATION.\*AK
