THIS IS THE SECOND GRAND VOYAGER. FIRST ONE NEVER HAD ANY PROBLEMS UNDER THE SAME DRIVING CONDITIONS. DEALER HAS NO EXPLANATION EXCEPT TO INCREASE TIRE PRESSURE.
