VEHICLE HAS A HISTORY OF STEERING PROBLEMS FROM PS PUMP TO RACK AND PINION COST OF REPAIRS ARE OUTRAGEOUS. MOST RECENT FAILURE LOCKED STEERING COMPLETELY WITH MY WIFE AND 6MO BABY DRIVING AT 75MPH ON INTERSTATE. HAS HAD NUMEROUS OTHER PROBLEMS WITH OIL SEALS, ELECTRICAL, IDLERS GOING OUT. SERPENTINE BELT BROKE DUE TO IDLER SEIZED AND SHUT DOWN POWER STEERING WHILE AT 75MPH IN A SEPERATE INCIDENT
