WE HAVE EXPERIENCED 3 FLATS ON THIS TIRE, REPAIRED BY A TIRE DEALER IN TOWN. LAST NIGHT, MY HUSBAND DROVE HOME AND EXPERIENCED ANOTHER FLAT ON SAME TIRE. WHEN HE TOOK IT OFF, THE SIDEWALL ON INSIDE HAD A HOLE MEASURING 2.5"X3". IF HE HAD BEEN DRIVING 75MPH (FREEWAY SPEED), THIS COULD OF RESULTED IN A SERIOUS, IF NOT FATAL, ACCIDENT. I HAVE BEEN TRYING TO FIND OUT WHO MANUFACTURES KIRKLAND TIRES AS THESE TIRES ARE ONLY 1 YEAR OLD AND WAS PURCHASED THROUGH COSTCO. I READ AN ARTICLE ABOUT SOME COOPER TIRES, NOT ON RECALL, BUT WITH SIDEWALL PROBLEMS. HAVEN'T HAD ANY LUCK IN MY RESEARCH. YOUR HELP WOULD BE GREATLY APPRECIATED. *AK
