**NYLON LINE WAS PINCHED WHEN CAR WAS ASSEMBLED RESULTING IN A FUEL LEAK WHICH PROGRESSED OVER MONTHS UNTIL FUEL WAS DRIPPING ONTO PAVEMENT. LEAK WAS SUFFICIENT TO CAUSE FIRE AND A SUBSTANTIAL AMOUNT OF POLLUTION. MANUFACTURER HAD NO TSB NOR WARRANTY COVERAGE. THIS WAS A DANGEROUS FAILURE WHICH WAS DIFFICULT TO "CATCH."\*\*AK**
