ACCORDING TO OWNERS MANUAL AIRBAGS ARE SUPPOSED TO BE DEPLOYED AT A THRESHOLD OF 9-18 MPH. THY DID NOT. CONTACTED GM DEALERSHIP AND THEY DO NOT WANT TO DO ANYTHING WITH THIS PROBLEM. I NEED YOUR HELP. MY HAND IS IN A CAST AND ACCORDING TO MY DOCTOR MAY NEED AN OPERATION TO MEND THE TORN LIGAMENTS IN MY HAND. I HIT THE STEERING WHEEL WITH MY CHEST. YET THE GM MANUFACTURER WILL NOT DO ANYTHING OTHER THAN EXPLAIN TO ME HOW THE AIR BAGS WORK. A VEHICLE CROSS MY PATH NOT YIELDING TO TRAFFIC AND CROSSED MY FRONT ABOUT 15 FEET AWAY. I HIT THE THE OTHER VEHICLE IN T-BONE TYPE ACCIDENT GOING AT 40 MPH, SPUNNED THE OTHER VEHICLE ABOUT THREE TIMES AND MY AIR BAG IN MY CHEVY S-10 TRUCK DID NOT DEPLOY. GM H
