I HAVE BEEN HAVING A PROBLEM WITH MY SAFETY BELT HARNESS FOR SEVERAL MONTHS NOW. I FEEL THIS IS A SAFETY HAZARD. WHEN I START TO LATCH MY SEAT BELT ON THE DRIVERS SIDE IT WILL TWIST AND I HAVE TO GET OUT OF THE CAR AND HELP IT RETRACKED. SOMETIMES IT WON'T RETRACK PROPERLY AND I HAVE TO WEAR IT AS IS. WHEN THE BELT ISN'T LIKE IT SHOULD BE AND IF I APPLY MY BRAKES TO SUDDENLY STOP IT WON'T CATCH LIKE A SEAT BELT IS SUPPOSED TO. I MADE AN APPOINTMENT ON 12/18/2001 TO HAVE THIS PROBLEM FIX AND THE DEALERSHIP SAID IT WAS CHECKED AND WAS FOUND TO BE IN NORMAL OPERATION. MY CAR DID NOT DO THIS UNTIL A COUPLE OF MONTHS AGO. I KNOW THIS IS NOT NORMAL AND I FEEL IT IS A MAJOR SAFETY HAZZARD. I AM A FAITHFUL SEATB
