NO MENTION OF ENGINE REPLACEMENT OR WHETHER OR NOT NEW GASKETS ARE ROOT CAUSE FIX OR SHORT TERM FIX. VEHICLE STILL UNDER MANUFACTURERS ORIGINAL FACTORY WARRANTY. THIS COMPONENT FAILURE IS UNACCEPTABLE FOR LATE MODEL/LOW MILEAGE VEHICLE. *AK
