PROBLEM IS AN INTERMITTENT, UNNECESSARY, SUDDEN DOWNSHIFT OF TRANSMISSION WHEN ASCENDING A STEEP, LONG GRADE. AFTER DOWNSHIFTING, THE TRANSMISSION WILL NOT UPSHIFT EVEN WHEN RPM'S APPROACH 5000, FORCING ME TO SLOW DOWN. THIS CREATES A DANGEROUS SITUATION IN HIGHWAY TRAFFIC.
