NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THERE IS A PROBLEM WITH THE RIGHT REAR BRAKE LIGHT. I HAVE NEEDED TO OPEN THE CASING UNIT ON FIVE SEPARATE OCCASIONS TO REPLACE THE BULB. WITHIN A WEEK'S TIME, HOWEVER, THE LIGHT IS NON-WORKING AGAIN. IT IS NOT THE BULB, BUT THE SOCKET THE BULB FITS INTO. THE LEFT REAR BRAKE LIGHT IS NOW HAVING THE SAME PROBLEM. UPON INSPECTION I NOTICE THE BULB ISN'T BURNT OUT BUT THAT THERE IS A SHORT OR BAD CONNECTION BETWEEN THE BULB AND SOCKET. I HAVE ON SEVERAL OCCASIONS DRIVEN AROUND WITH ONLY THE BRAKE LIGHT IN MY REAR WINDOW WORKING. THIS IS A DEFINITE SAFETY ISSUE! ALSO, THE BRAKING SYSTEM ON THIS MODEL VEHICLE IS TERRIBLE. THE BRAKES WEAR OUT AROUND 10,000 MILES AND THE CAR SHIMMIES AND SHAKES. BEFORE
