I FEEL THAT RICK PEREZ AUTO NET DEALERSHIP HAS SOLD ME A DEFECTIVE CAR. 2 WEEKS AFTER I BOUGHT THIS CAR I HAD TO RETURN IT FOR SEVERAL DIFFERENT DEFECTS. I HAVE LOOKED UP THE LEMON LAW AND IT STATES THAT THERE MUST BE A REOCCURRING PROBLEM. ON MY CAR IT IS SEVERAL THINGS, SOME OF THEM HAVE OCCURRED MORE THAN ONCE. I HAD TO REPLACE MY BRAKES 6 MONTHS AFTER I GOT THE CAR CAUSED BY A VIBRATION FROM THE FRONT END AND HAVE REPLACED THEM A TOTAL OF 3 TIMES SINCE I GOT THE CAR. 1 YEAR AFTER I GOT THE CAR, HAD TO GET NEW TIRES PUT ON DUE TO WEARING OF THE TREADS AND LOSING AIR IN THE FRONT TIRES, AGAIN DUE TO THE VIBRATION, I PAID FOR THAT.
