IN MY EXPERIENCE THIS IS AN EXTREMELY DANGEROUS BEHAVIOR. SOME OF THE CAR MAGAZINES ACTUALLY DO NOT RECOMMEND PURCHASE OF THIS CAR DUE TO THIS CHARACTERISTIC. AUDI DOES NOT ACKNOWLEDGE THE PROBLEM.
