I WAS TOLD IF I WANTED TO PAY THE \$2,000.00 BILL THEY WOULD BE HAPPY TO ORDER THE PARTS. THE HEAD LAMPS ARE SO DIM I HAVE NEARLY HIT DEERS IN THE ROAD ON 5 SEPERATE OCCASIONS I KNOW THESE CAN'T PASS FMVSS REQUIREMENT. THE DRIVERS SEAT IS LOOSE IN THE TRACK AND ROCKS WHEN ACCELERATING AND STOPPING. THE FRONT STRUTS MOUNTING BRACKETS RATTLE, SHAKE, VIBRATE AND BANG. THE STEERING WHEEL VIBRATES WHILE TURNING. THE REAR STUTS ARE TOO WEAK FOR THE VEHICLE SO PEOPLE CAN'T RIDE IN THE REAR OR THE CAR BOTTOMS OUT. THE CAR ALARM SOMTIMES WORKS AND :
