NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THE INCIDENT DATED 12/21/01 OCCURED AS THE VEHICLE EXITED OFF THE FREEWAY IN SAN PEDRO, CA. MY BROTHER WAS DRIVING AND WAS AWARE OF THE PREVIOUS BRAKE PROBLEMS THAT HAVE OCCURRED IN RAINY CONDITIONS. THE VEHICLE FOLLOWED THE OFFRAMP AT 25 MPH. WE HAD AMPLE DISTANCE BETWEEN THE US AND THE CAR IN FRONT. AS THE CAR CAME TO A SLOW DOWN, MY BROTHER STEPPED ON THE BRAKES BUT THEY DID NOT WORK. THERE WAS A RUMBLING SOUND AS THE TIRES KEPT ROTATING. HE VEERED OVER TO THE LANE TO OUR LEFT SO AS NOT TO HIT THE CAR IN FRONT OF US. THE VEHICLE CONTINUED TO SLIDE ABOUT 10 MORE FEET ON ITS OWN UNTIL MY BROTHER PULLED ON THE EMERGENCY BRAKE. AS THIS WAS HAPPENING AN 18 WHEELER TRUCK WAS
