NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

THIS MODEL HAS THE MANUAL TRANSFER CASE SHIFT LEVER. ALTHOUGH THE LEVER MOVES CORRECTLY IN THE VARIOUS POSITIONS, SUCH AS 2WD., 4WD. HIGH 4WD. LOW, NEUTRAL AND MAKES THE USUAL NOISES WHEN SHIFTING, THE FOUR WHEEL DRIVE IS NOT ENGAGING NOR IS THE INDICATOR LIGHT, SHOWING THE FRONT AXLE IS ENGAGED, LIGHTING UP. THIS HAS CAUSED SEVERAL CLOSE CALLS IN "ALMOST ACCIDENTS" AND ALMOST BEING STRANDED. WE LIVE IN A RURAL SETTING WHERE THERE IS A 11 MILE DISTANCE BETWEEN SOME NEIGHBORS AND VERY SPARSE CELL PHONE ACCESS. THE POINT BEING THAT WHEN WE BUY A VEHICLE WITH 4 WHEEL DRIVE, WE EXPECT IT TO WORK AND OUR LIVES DEPEND ON IT! IN THIS CASE A FRONT WHEEL DRIVE CAR WOULD PROVIDE BETTER TRACTION!
