AGAIN REPLCED WITH X RADIAL PLUS.ON SECOND FAILURE TIRE WAS SERIOUSLY OUT OF ROUND AND COULD HAVE CAUSED A SERIOUS ACCIDENT AT INTERSTATE SPEED OF 65MPH.
