I UNPLUGGED THE ABS UNDER THE TRUCK AND DROVE IT TO A REPAIR SHOP. I WAS TOLD THIS IS A COMMON PROBLEM. WHEN THE GARAGE PICKED UP THE PART AT THE GMC DEALERSHIP, THEY WERE TOLD THIS IS A COMMON PROBLEM AND THEY COULDN'T KEEP ENOUGH CONTROL MODULES IN STOCK. THIS IS A DEALER PART #88935872 "ABS CONTROL MODULE WITH A COST OF \$682.50. TOTAL COST OF THE REPAIR WAS \$839.77. (THE DEALER WOULD HAVE CHARGED MORE). MY FIRST CONCERN IS THAT MANY DRIVERS WOULD NOT HAVE NOTICED THE PROBLEM AND SEC
