NARRATIVE DESCRIPTION OF FAILURE(S), INCIDENT(S), INJURY(IES)

ON THE 12TH OF NOVEMBER I WAS ABOUT 1.5 BLOCKS AWAY FROM A STOP SIGN AND SHIFTED DOWN AS I APPROACHED WHILE APPLYING MY BRAKES. THE BRAKES LOCKED UP AND I WAS UNABLE TO STEER OR STOP. I THEN ENDED UP HITTING A FENCE. THE SECONUD TIME THAT THE BRAKES LOCKED UP I WAS COMING FROM BIG O (GETTING NEW TIRES BECAUSE I HAD TO REPLACE ONE THAT WAS RUINED DUE TO THE PREVIOUS ACCIDENT). AS I LEFT THE PARKING LOT (WITH NEW TIRES) MY BRAKES LOCKED UP AND I SLID INTO TRAFFIC, LUCKILY THE TRUCK SEEN ME AND TURNED IN THE OPPOSITE DIRECTION. THE THIRD TIME THAT THEY LOCKED UP WAS TWO MONTHS LATER WHEN I WAS IN CASPER, WY. I WAS STOPPING TO PULL OVER AND PARK, THE BRAKES AGAIN LOCKED UP AND I HAD NO CONTROL OVER MY C
