ALL THREE TIMES THEY REPLACED THE TRANSFER CASE SWITCH. THE SUV IS STILL LOCKING INTO 4-WHEEL HI WHILE DRIVING. JAN.2 I ALMOST WRECKED BECAUSE IT ENGAGED AT 35-40 MILES PER HOUR WHILE GOING AROUND A BEND. THE VEHICLE HAD TO BE SHUT OFF TO DISENGAGE THE 4-WHEEL DRIVE SYSTEM. I HAVE CONTACTED GM ABOUT THIS PROBLEM AND THEY ARE BASICALLY IGNORING IT. PLEASE HELP FIND OUT WHAT THE PROBLEM IS BEFORE SOMEONE IS HURT .*AK
