ONLY TO HAVE THE DEALER TELL US THAT THE WARRANTY WILL NOT COVER THIS "REAREND WIND-UP" AS IT IS A REGULAR MAINTANANCE ITEM. I HAVE SEARCHED THE OWNERS MANUAL FOR THIS ITEM AND HAVE NOT FOUND IT AS A MAINTANENCE ITEM, ACCORDING TO GM. AT ALL SERVICE INTERVALS THE ONLY MENTION OF THE REAREND IS TO CHECK THE FLUID LEVEL. THIS HAS BEEN CARRIED OUT BY THE DEALER FOR THE FIRST 45,000 MILES. I H
