WHEN MY VEHICLES BRAKES ARE DEPRESSED WITH UNEVEN SURFACE TRACTION ON THE LEFT OR RIGHT SIDE OF THE WHEELS, THE ABS SYSTEM DELAYS AND DOES NOT ENGAGE THE BRAKES FOR 1 TO 3 SECONDS. THIS HAPPENED TODAY ON A SMOOTH SUBURBAN STREET WITH WATER CONTACTING ONLY THE RIGHT SIDE WHEELS. WHEN I WENT TO BRAKE FOR AN UPCOMING STOP SIGN, THE BRAKES DID NOT ENGAGE AT ALL FOR APPROXIMATELY 2 SECONDS. IT WAS EXTREMELY FRIGHTENING. I AM REPORTING THIS BECAUSE IT SEEMS IT IS AN UNACKNOWLEDGED PROBLEM WITH A LOT OF THE MODEL YEAR 2002 SUBARU IMPREZZA WRX CARS. THERE IS A DISCUSSION ON THIS ISSUE ON AN OWNERS CLUB BULLITEN BOARD CALLED THE I-CLUB (WWW.I-CLUB.COM). I DID NOT BELIEVE IN THIS PROBLEM UN
