ONE DAY WHILE DRIVING THE CAR, I TRIED TO MAKE A LEFT TURN. THE STEERING BEGAN TO TIGHTEN UNTIL IT WAS ALMOST UNABLE TO ROTATE. IT IS NOT AS DIFFICULT TO TURN AT HIGH SPEEDS, YET IT IS STILL VERY RESISTANT. THE STEERING HAS NOT BEEN REPAIRED YET DUE TO FINANCIAL DIFFICULTIES. TO TURN THE WHEELS AT A STAND STILL IS ALMOST IMPOSSIBLE. I AM STRONGER THAN THE AVERAGE MALE (220LBS. 5'11"). MY WIFE IS UNABLE TO MOVE IT. I SAW AN ARTICLE IN THE USA TODAY THAT MENTIONED THAT YOU WERE INVESTIGATING REPORTS OF THIS SITUATION OCCURRING IN SPECIFICALLY, THE 1997 GRAND PRIX. I WOULD VERY MUCH APPRECIATE IT IF YOU COULD CONTACT ME SO THAT I MAY ANSWER YOUR QUESTIONS AND ALSO KEEP ME UPDATED ON WHETHER THIS REPAIR WILL BE COVERED
