SINCE 1997, VEHICLE HAS HAD PROBLEMS WITH THE CHECK ENGINE LIGHT. RESPONSE FROM FORD WAS THAT DUE TO THE LARGE NUMBER OF SENSORS THAT ACTIVATE THE LIGHT, IT WOULD BE IMPOSSIBLE TO TELL WHAT WAS SETTING IT OFF. THEN TOLD FORD TO RUN PCM DIAGNOSTIC TEST TO OBTAIN CODES, DIDN'T KNOW WHAT I WAS TALKING ABOUT. FINALLY GOT THEM TO DO IT, AND IT CAME UP WITH FAULTY O2 SENSOR. REPLACED SENSOR, AND PROBLEM PERSISTED. WENT BACK, RAN TEST, CAME BACK WITH SAME RESULTS. FORD HAS BEEN NO HELP, CONTACTED FORD, SAID NOT SAFETY RELATED, THEREFORE NOT THEIR PROBLEM.
